Further to inform that BOPT (ER) along with other Regional Boards has been continuously striving to provide more better platform through National Webportal by continuously simplifying and updating the existing work flow. I am writing this communication to draw your attention to an important subject as mentioned above. It has been observed from records that the training establishments are raising request for issuance of Certificate of Proficiency after a time lapse of more than one year from the date of completion of the training. Also to note that the requisition for issue of Certificate of Proficiency by the training establishments is a mandatory requirement since it contains the recommendation based on the assessment of the skill developed during training period.

Hence, in order to make the release of Certificate of Proficiency on time by BOPT (ER), Kolkata it is hereby informed that all training establishments who have engaged apprentices till 31.03.2017 and have not raised/submitted requisition for issuance of Certificate of Proficiency as per the process document requirement must do the same on or before 31.08.2017. Any requisition received after 31.08.2017 in respect of apprentices who completed their training on or before 31.03.2017 shall not be entertained by BOPT (ER).

It is hoped that with your help and cooperation and implementation of new system of online generation of Skill Assessment Sheet and Certificate of Proficiency, no further backlog will be created.
