Subject: Holding of awareness workshops on Draft National Credit Framework (NCrF)–Reg.

Sir,

I am directed to say that this Ministry launched the draft of **National Credit Framework (NCrF)** on 19th October 2022 for public consultation and the comments by 30th November 2022.

2. Under the provisions of the National Education Policy (NEP) 2020, a High-Level Committee constituted by this Ministry has developed a draft NCrF, to enable the integration of academic and vocational domains and to also ensure flexibility and mobility between these two. NCrF would be a game changer by opening numerous options for further progression of students and inter-mingling of school and higher education with vocational education and experiential learning, thus mainstreaming skilling and vocational education. NCrF will also enable dropped out students from the mainstream education to re-enter the ecosystem.

3. As the credit systems has been working in the Indian Institute of Technology (IITs) since long, a half day awareness workshop steered by the IITs is being organised in five zones namely North Zone (IIT Delhi), West Zone (IIT Bombay), North-East Zone (IIT Guwahati), East-Central Zone (IIT Bhubaneswar) and South Zone (IIT Madras) to develop the understanding about the NCrF and its implementation among the school education, higher education, engineering and vocational education & skill ecosystems. The schedule along with details of stakeholders and respective responsibilities is at Annexure A. The tentative Program of the workshop is at Annexure B. The workshop will be organised in blended mode wherein about 200 participants will be attending physically and many more could join through a web link.

4. You are requested to give wide publicity about this NCrF workshop and nominate the institutes/organisations under your control to participate in the workshop (offline mode) being organised in their respective zones. The details of participants for each zone may be forwarded to NCVET and host IITs as per the format at Annexure C. The details of venue for physically attending the workshop and the Web link for viewing the workshop online shall be shared by the host IITs.



5. The host IITs are requested to coordinate and make all necessary arrangements for the conduct of NCrf workshops. Detailed comments, suggestions, and feedback received in the workshop on NCrf may be forwarded to this office within five days of the conduct of the workshop for consideration and inclusion in NCrf.
